



ATO — March of Dimes "Run For Life"

Dear Brothers,

As all of you well know, we here at Zeta Lambda have a fine tradition of service to the community. However, in recent years, the social service facet of the fraternity has become an option rather than a priority. It was just this past semester that the fraternity saw the need to change this attitude and again place pride in our civic duties. I personally believe the chapter has chosen an avenue which will continue to grow and prosper and bring much needed **good** publicity to ATO. It is called the ATO March of Dimes Run For Life.

It all began early last semester when the thought of a good social service project became a priority. We wanted something worthwhile, a project that would involve everyone. It had to be fun but still do its job in helping out a good cause. The cause became the March of Dimes. The next problem was deciding what we were going to do for them. With the emphasis placed today on physical fitness and running, we chose to run for those who could not. Zeta Lambda sponsored a 10,000 meter cross country run and a 1 mile fun run. With the idea in the head, the planning and preparation started. We decided to charge only an entry fee for the runners and that all proceeds would go to the March of Dimes. T-shirts, trophies and ribbons were to be awarded to participants in the race. This ran into quite an expense. Brothers canvassed the Murray area soliciting donations from businesses in

return for free advertising (besides a good tax write-off). The money collected from the businesses went to pay for expenses of the race. It seemed as if the details became more involved the further along we went. Taking care of registration, marking off the course, getting race equipment, all became somewhat trying on the patience. It could not have been done without the help of Brother Greg Fox, who happens to be in the top 5 on the Murray State Track Team. Greg took care of all the details of the race itself and was instrumental in planning the race. But I guess if you've run in as many marathons as he, it might get to be old hat.

However, through some good fortune, the details were taken care of and the day of the run arrived. Since we had no advance registration, we had no idea how successful it would be. Were we ever surprised! Over 70 runners were on hand that day ready to tackle a grueling 6.2 mile course over the outskirts of Murray. The race was started with our old faithful canon posing as a starting gun, and it took just over 29 minutes for the top finisher to finish. For you runners out there, you know that is an outstanding time. Those were some notable participants in the race. The 1969 OVC Championship Track Team, Coach Bill Cornell, Drs. Adam Lanning and Adam Hough along with several community leaders and tracksters from Paducah, Mayfield, Paris, Tenn. and Marshall County. After the awards ceremony, almost all of the runners commented on the smoothness of the race,

the quality of the course and awards and the fun they had running. It turned out to be a bigger success than imagined.

If you think I sound excited about this, you're right. This was a shot in the arm that Zeta Lambda needed. With advertising in 4 newspapers, 17 radio stations and television, ATO received publicity that wasn't retorting fraternity life for a change. The Run For Life will return this spring, bigger and better than last year. And I hope it returns for many years to come. It is an expensive undertaking. It was confined to a small scale this year and yet our cost was over \$800. We still broke even, however, and donated almost \$250. to the March of Dimes. If you alumni would like to help, just drop a check in the mail and stipulate it is for the Run For Life. Remember, it's tax deductible and any donation would be a greatly appreciated gift.

My thanks go the alumni who have businesses in Murray as their financial and moral assistance was a necessity. I also want to thank the brothers and little sisters of Zeta Lambda for a job well done. Without everyone's help, none of this would have been possible. Be watching for more info on the 2nd Annual ATO March of Dimes Run For Life. We'll make sure you get the word in plenty of time to get in shape and make a weekend out of it at the frog house.

able to get some of the furniture reupholstered in the house; also we steam-cleaned the carpet in the house and replaced the windows that got broken out by the "ghost".




Randy House


